INDICTMENT

THE GRAND JURY CHARGES THAT:

COUNT ONE

From on or about April 27, 2001, and continuously thereafter up to June 13, 2001, in the
Houston Division of the Southern District of Texas,

GUSTAVO CAMARGO AZUARA
JUAN CARLOS MORFIN
and
SAMUEL TORRES HERNANDEZ

defendants herein, and others unknown to the Grand Jury, did unlawfully, knowingly and
intentionally combine, conspire, confederate and agree with each other to commit an offense
defined in Title 21 United States Code, Section 841 (a)(1), that is, to possess with the intent to
distribute a controlled substance. The violation involved 500 grams or more of a mixture and
substance containing a detectable amount of cocaine, a Schedule II Controlled Substance.

In violation of Title 21, United States Code, Sections 841(a)(1) and 841(b)(1)(B)(ii) and
846.
